- 4. For all waste or used tires collected for retreading or recapping, the quantity and type collected, and the name and location of the retreading/recapping facility receiving the tires. If the tires collected were not consigned to the originally reported facility, the actual disposition of the tires must be recorded.

For renewal purposes, you will be required to submit to the department a disclosure statement if there is a change and an annual report and renewal application summarizing the information collected under the preceding paragraph. The information must be submitted on Form TAP-2 (Waste Tire Transporter Annual Report and Renewal Application) provided by the department with the yearly renewal information packet. As a waste tire transporter licensee, you are required to maintain insurance on your vehicle(s) at all times in the business or business owner(s) name(s).
